### Levee Board

The Board of Mississippi Levee Commission has three members who are up for re-election this year. They are Jimmy House, in Bolivar County; Fred Ballard, in Washington County; and Roy Nichols, in Issaquena County. The scheduled election date is June 6th with a run-off, if necessary, to be held June 20th. All candidates for these positions must have their petitions filed with a minimum of 50 signatures of registered voters. These petitions must be filed prior to close of business on May 5, 2000.

The Mississippi Levee Board encompasses the counties of Bolivar, Washington, Sharkey, Issaquena, and parts of Humphreys and Warren Counties. The Board is the local sponsor for the Corps of Engineers projects on the levee and on interior streams. The primary responsibility includes right-of-way acquisition and maintenance of completed work.

The Mississippi Levee Board is funded by an ad valorem tax (currently 2.19 mils) and on acreage tax (currently 5 cents per acre or parcel if less than one acre).

### **Precinct Caucus**

The Republican Precinct Caucus will be held at 10:00 a. m. Saturday, April 29th at your usual voting place. Any person who is a qualified elector of the precinct may participate. The County Chairman has selected a temporary chairman for each precinct. If the temporary chairman fails to arrive, the first person at the caucus will assume the duties of this individual. He will call the meeting to order and then elect a permanent chairman to preside. One person can constitute a valid precinct meeting. He can elect himself and any other qualified elector in his precinct as delegates and alternate delegates to the County Convention. The table below lists the number of delegates and alternates for each precinct. All delegate and alternate positions do not have to be filled in order to have a valid delegation. The precinct Chairman will list the names and addresses of the delegates and alternates as well as those attending the caucus and then sign the list to certify it. This must be done for the precinct delegation to be recognized at the County Convention. The County Convention will be held at 3:00 p.m., Saturday, April 29th, in the Chancery Courtroom at the County Courthouse.

## **Election Commissioner**

The responsibility for preparing the official ballot and generally overseeing each election for county offices falls to the Washington County Election Commissioners. By statute Washington County has five such posts, one for each of the five Supervisor Districts. One Commissioner is elected from each district and that Commissioner must reside in the district electing him. The next opportunity we will have to run for and vote for these positions is in the general election in the fall of this year.

In order to qualify to run for this office a candidate must circulate a petition for his or her candidacy and must secure the signatures of at least fifty registered voters residing in the district the candidate wishes to represent. This petition must request the candidacy of the individual wishing to run for the office and must declare his or her party affiliation. The petition must be filed with the Circuit Clerk of Washington County no less than sixty days before the election and it is the burden of the Circuit Clerk to examine the petition and determine that the names of at least fifty registered voters appear on the petition. If the Circuit Clerk determines that this requirement is met the petition is transmitted to the President of the Board of Supervisors and the President assures that at least fifty of the electors signing the petition reside in the same district as the candidate, the district in which the candidate intends to run. If this requirement is confirmed as satisfied the President of the Board of Supervisors sends the petition to the current Secretary of the Election Commission for the qualified candidate to be placed on the next official ballot as a candidate for Election Commissioner.

In order to be elected to the post of Election Commissioner a candidate must receive a majority of the votes cast. If a run-off is required it will be held two weeks later to determine a victor. Once the new Election Commission in place the Commission will elect, from its members, a President and a Secretary. It is the ultimate responsibility of the Chairman to print and distribute official ballots for all countywide elections. During the course of his or her term, no Election Commissioner may run for any other county office.

Washington County's current roster of Election Commissioners includes Arlelia Moreland - District 3, Linda Boschert - District 1, David Weathersby - District 4, Francis Whitacre - District 2, and William Burnside -District 5. - - -Brad Golmon
